

Remuneration for Board of Directors and Committees

Board of Directors Meeting

Board of Directors is required to meet at least once a month with advance meeting schedule throughout the year. Each Director is required to attend every Board meeting with devotion at full interest. However, meeting quorum requires at least half of the total number of Board members in order to constitute a quorum. During any meeting with conflict of interest, Board members at stake must vacate the meeting room. Voting on resolution requires majority and must record any member's discrepancy into the meeting minute.

The Company Secretary is responsible for supporting the Board meeting procedures by sending meeting invitation letter, meeting agenda, and meeting document to each member of the Board at least 7 days in advance except those previously screened by specialized committees requires 3 days advance submission. Written meeting minute must also be submitted to Board of Directors within 14 days after the meeting and properly store such certified documentation for further verification.

Remuneration for Board of Directors

Board of Directors has appointed a Remuneration Committee to consider compensation for members of the Board e.g. salary, meeting allowances, bonuses, etc. corresponding to the Cabinet resolutions and Ministry of Finance's regulation.
